This Cookies Policy is an integral part of the Legal Texts and the Privacy Policy of the:

- (i) Website https://www.eurocoinpay.io (hereinafter, the "Website"), as well as
- (ii) of the mobile application *EurocoinPay* (hereinafter, the "Application") owned by EUROCOIN BROKER SA (hereinafter, "*EurocoinPay*"), with NIF A24699704, with address at Calle La Raya 110, 24010, Trobajo del Camino, León (Spain), and email for privacy purposes gpdr@eurocoinpay.io.

Access and navigation on the Website and the Application, as well as the acceptance of the banner corresponding to the cookies and their configuration imply the acceptance of the terms and conditions in this Privacy Policy.

In order to facilitate navigation through the Website and the Application, *EurocoinPay*, informs you that it uses cookies or other files of similar functionality (hereinafter, "Cookies").

In any case, we inform you that *EurocoinPay* is responsible for these Cookies and the processing of the data obtained through them, deciding on the purpose, content and use of the processing of the information collected.

### WHAT IS UNDERSTOOD BY A COOKIE?

Cookies are files that contain small amounts of information that are downloaded to the user's device when he visits a web page or an application, associating only an Anonymous user and his device and sometimes, they provide evidence that allows access to the user's personal data.

Cookies are essential for the functioning of the Internet, their main purpose is to recognize the user each time they access the Website or the Application, allowing, in addition to improving the quality, offering a better use of both environments, personalizing the services offered in this and offering the user information that is of interest or that may be of interest, in attention to the use made of them.

### 2. USE OF COOKIES BY EUROCOINPAY

Users expressly authorize the use of this information for the indicated purposes, through the channels enabled for this purpose on the Website or the Application, without prejudice to their right to reject, disable or configure the use of Cookies. If Cookies are deactivated or rejected, navigation through the Website or the Application may not be optimal and some of the utilities available may not work correctly.

Specifically, *EurocoinPay* is using Cookies for the purposes set out below. If in the future *EurocoinPay* uses other Cookies in order to provide more and better services, the user will be informed of this.

The installation of these Cookies on the user's device will always occur after the collection of consent and/or configuration of these.

In this Cookies Policy, all the Cookies used in the Application and the Website are generally informed. However, for informational purposes for the user, the Cookies are necessary for the operation of the Application or the Website will be activated by default, and may be, where appropriate, deactivated and rejected by the user, always in compliance with the current regulations.

#### 3. Types And Objectives Of The Cookies Used

Both the Website and the Application use own and third-party cookies. According to the entity that manages the data obtained through Cookies, they are grouped as follows:



- Own: Those that are sent to the editor that provides the service requested by the user.
- Third parties: They are not managed by the editor, but by a third party who is the one who manages the data obtained through Cookies.

Depending on their permanence:

- Session: They remain during access and navigation on the site, they are deleted once the user leaves the Website or the Application.
- **Permanent:** They remain stored in the terminal and can be accessed and processed during a period of time defined by the person responsible for the Cookie.

### 4. COOKIES USED ON THE WEBSITE OR THE APPLICATION

The Cookies used by *EurocoinPay* are own and third-party cookies.

### 4.1. Necessary Cookies

They are those cookies considered essential for browsing through both environments, as they facilitate the user to use their features or tools, such as, for example, identifying the session, accessing restricted access parts, guaranteeing browsing safety. Without these cookies, the aforementioned functions would be disabled.

In this sense, *EurocoinPay* uses its own cookies for the following purposes:

- Identify the user's session to keep it active while browsing.
- Identify the user's session to avoid possible attacks.
- Identify the user's cookie settings.
- Web firewall security configuration.
- Verify the connection with the servers (in these cases, these Cookies may be from third parties, but they will always have the purpose described).

### 4.2. Analytical Cookies

*EurocoinPay*, through the Website and the Application, uses its own Cookies for the security of both environments and at an analytical level. Specifically, these Cookies are:

### **GOOGLE ANALYTICAL COOKIES**

*EurocoinPay*, through the Website and the Application, uses Google Analytics (in no case will they be permanent Cookies), a service provided by Google, Inc., an entity whose main office is at 1600 Amphitheatre Parkway, Mountain View (California), CA 94043, United States ("Google").

Google Analytics uses Cookies for the purpose of analysing the use made by users of the Website or the Application. The information generated by the Cookie (including your IP address) will be directly transmitted and filed by Google on its servers in the United States.

Google will use this information on behalf of *EurocoinPay* in order to know the use of the Website or the Application by users, compiling reports on their activity and providing other services related to the activity of the Website or the Application and the Internet use. Google may transmit said information to third parties when required by law, or when third parties process the information on behalf of Google, including *EurocoinPay*. Google will not associate your IP address with any other data it has.

#### 5. USER CONFIGURATION TO AVOID COOKIES
